STANDARDS OF BUSINESS ACTIVITIES ON THE IMPLEMENTATION OF
RISK-BASED BUSINESS LICENSES IN THE TOURISM SECTOR

THE REPUBLIC OF INDONESIA,

Considering : that in order to implement the provisions of Article 6 section (7) and Article 142 section (4) of Government Regulation Number 5 of 2021 on Implementation of Risk-Based Business Licensing, it is necessary to stipulate a Regulation of the Minister of Tourism and Creative Economy/Head of the Tourism and Creative Economy Agency on Standards of Business Activities on the Implementation of Risk-Based Business Licensing in the Tourism Sector;

Observing : 1. Article 17 section (3) of the 1945 Constitution of the Republic of Indonesia;

HAS DECIDED:

To issue : REGULATION OF THE MINISTER OF TOURISM AND CREATIVE ECONOMY/HEAD OF THE TOURISM AND CREATIVE ECONOMY AGENCY ON STANDARDS OF BUSINESS ACTIVITIES ON THE IMPLEMENTATION OF RISK-BASED BUSINESS LICENSES IN THE TOURISM SECTOR.

Article 1

The Minister stipulates business activity standards in the implementation of risk-based business licensing in the tourism sector as listed in the Annex which is an integral part of this Ministerial Regulation.

Article 2

The risk-based business licensing in the tourism sector as referred to in Article 1 is implemented through One Single Submission System.

Article 3

At the time this Ministerial Regulation comes into force, all Ministerial Regulations that regulate business activity standards in the administration of business licensing in the tourism sector are declared to remain valid as long as they do not conflict with this Ministerial Regulation.

Article 4

The One Single Submission System as referred to in Article 2 begins to be implemented since the business licensing process is carried out as a whole as regulated in Government Regulation Number 5 of 2021 on Implementation of Risk-Based Business Licensing.

Article 5

This Ministerial Regulation comes into force on the date of its promulgation.

In order that every person may know hereof, it is ordered to promulgate this Ministerial Regulation by its placement in the State Gazette of the Republic of Indonesia.
